Cooking instruction oven

Preheat the oven at 220°C. Spread the preferred quantity equally on the baking tray and place the tray in the middle of the oven. Bake the gratin 20-25 minutes.



Cooking instruction combisteamer

Set the steamer to 'convection', 200°C and bake the product for 15 to 18 minutes.
